**WE ARE COMMITTED** to the principle of separation of church and state.

**WE CULTIVATE** the arts of negotiation and compromise as a means of resolving differences and achieving mutual understanding.

**WE ARE CONCERNED** with securing justice and fairness in society and with eliminating discrimination and intolerance.

**WE BELIEVE** in supporting the disadvantaged and the handicapped so that they will be able to help themselves.

**WE ATTEMPT** to transcend divisive parochial loyalties based on race, religion, gender, nationality, creed, class, sexual orientation, or ethnicity and strive to work together for the common good of humanity.

**WE WANT TO PROTECT** and enhance the earth, to preserve it for future generations, and to avoid inflicting needless suffering on other species.

We believe in enjoying life here and now and in developing our creative talents to their fullest.

**WE BELIEVE** in the cultivation of moral excellence.

**WE RESPECT** the right to privacy. Mature adults should be allowed to fulfill their aspirations, to express their sexual preferences, to exercise reproductive freedom, to have access to comprehensive and informed health-care, and to die with dignity.

**WE BELIEVE** in the common moral decencies: altruism, integrity, honesty, truthfulness, responsibility. Humanist ethics is amenable to critical, rational guidance. There are normative standards that we discover together. Moral principles are tested by their consequences.

**WE ARE DEEPLY CONCERNED** with the moral education of our children. We want to nourish reason and compassion.

WE ARE ENGAGED by the arts no less than by the sciences.

**WE ARE CITIZENS** of the universe and are excited by the discoveries still to be made in the cosmos.

**WE ARE SKEPTICAL** of untested claims to knowledge, and we are open to novel ideas and seek new departures in our thinking.

**WE AFFIRM HUMANISM** as a realistic alternative to theologies of despair and ideologies of violence and as a source of rich personal significance and genuine satisfaction in the service to others.

WE BELIEVE in optimism rather than pessimism, hope rather than despair, learning in the place of dogma, truth instead of ignorance, joy rather than guilt or sin, tolerance in the place of fear, love instead of hatred, compassion over selfishness, beauty instead of ugliness, and reason rather than blind faith or irrationality.

#### **DADT**

"Don't ask, don't tell" (DADT) was the official United States policy on homosexuals serving in the military from December 21, 1993 to September 20, 2011. The policy prohibited military personnel from discriminating against or harassing closeted homosexual or bisexual service members or applicants, while barring openly gay, lesbian, or bisexual persons from military service. The restrictions were mandated by United States federal law Pub.L. 103-160 (10 U.S.C. § 654). The policy prohibited people who demonstrate a propensity or intent to engage in homosexual acts" from serving in the armed forces of the United States, because their presence "would create an unacceptable risk to the high standards of morale, good order and discipline, and unit cohesion that are the essence of military capability." The act prohibited any homosexual or bisexual person from disclosing his or her sexual orientation or from speaking about any homosexual relationships, including marriages or other familial attributes, while serving in the United States armed forces. The act specified that service members who disclose that they are homosexual or engage in homosexual conduct should be separated (discharged) except when a service member's conduct was "for the purpose of avoiding or terminating military service" or when it "would not be in the best interest of the armed forces".

The "don't ask" part of the DADT policy specified that superiors should not initiate investigation of a service member's orientation without witnessing disallowed behaviors, though credible evidence of homosexual behavior could be used to initiate an investigation. Unauthorized investigations and harassment of suspected servicemen and women led to an expansion of the policy to "don't ask, don't tell, don't pursue, don't harass."

A congressional bill to repeal DADT was enacted in December 2010, specifying that the policy would remain in place until the President, the Secretary of Defense, and the Chairman of the Joint Chiefs of Staff certified that repeal would not harm military readiness, followed by a 60-day waiting period. A July 6, 2011 ruling from a federal appeals court barred further enforcement of the U.S. military's ban on openly gay service members. President Barack Obama, Secretary of Defense Leon Panetta, and Chairman of the Joint Chiefs of Staff Admiral Mike Mullen, sent that certification to Congress on July 22, 2011, which set the end of DADT for September 20, 2011.

#### **DOMA**

The **Defense of Marriage Act (DOMA)** (Pub.L. 104-199, 110 Stat. 2419, enacted September 21, 1996, 1 U.S.C. § 7 and 28 U.S.C. § 1738C) is a United States federal law whereby the federal government defines marriage as a legal union between one man and one woman. Under the law, no U.S. state (or other political subdivision) may be required to recognize as a marriage a same-sex relationship considered a marriage in another state. The law passed both houses of Congress by large majorities and was signed into law by President Bill Clinton on September 21, 1996.

The law, specifically Section 3, codifies an irrecognition of same-sex marriage for all federal purposes, which include family insurance benefits for employees of the government, survivors' benefits from Social Security, and joint tax filings. This section has been found unconstitutional in two Massachusetts court cases and a California bankruptcy court case; however, the court rulings are under appeal. The Barack Obama administration has called parts of the law unconstitutional, and announced in 2011 that while they will enforce DOMA, they will not defend it in court. Shortly thereafter, House of Representatives announced it would defend the law on behalf of the federal government in place of Obama's Department of Justice.



## Church & STATE

#### **OUTRAGEOUS RELIGIOUS RIGHT MYTHS:**

**#1:** *Pulpit politicking is legal.* Under federal law, tax-exempt, non-profit groups are barred from intervening in elections by endorsing or opposing candidates. This includes houses of worship. This law's application to churches has been upheld by a federal appeals court.

#2: The American people support church electioneering. Poll after poll has shown strong opposition to pulpit politicking. Opposition sometimes reaches 80%. Even polls sponsored by conservative religious groups have found solid opposition to pulpit politicking among church-goers as well as clergy.

#3: Americans are accustomed to hearing partisan sermons in churches. Increasingly, Americans are telling pollsters that they don't view houses of worship as centers of partisan politics, and most clergy say the same thing. People are part of religious communities for spiritual reasons, not to get orders on how to vote.

#4: Houses of worship are being muzzled and sermons are being censored. Religious leaders and organizations can—and many do—speak out a wide range of spiritual, moral and political issues. But if houses of worship want to keep their tax exemption, they cannot endorse candidates or use congregational resources to intervene in partisan campaigns.

#5: The Internal Revenue Service never enforces the no-politicking law against religious groups. In 1995, the IRS revoked the tax exempt status of a New York congregation that took out newspaper ads opposing a presidential candidate. TV preacher Pat Robertson's Christian Broadcasting Network lost its exemption for two years and paid a monetary penalty for partisan politics, and the late Jerry Falwell's Old Time Gospel Hour suffered the same fate.

# SUSAN G. KOMEN FOR A CURE V. PLANNED PARENTHOOD

When the nation's largest advocacy group for the cure and prevention of breast cancer, Susan G. Komen Race For a Cure, announced a decision January 31 to discontinue grants to Planned Parenthood for breast cancer screenings, foes of reproductive choice stood and cheered. Katie Pavlich, News Editor at Townhall. com, joyously blogged: "I may be doing my first Susan G. Komen Race for the Cure this summer; they've cut ties with Planned Parenthood." She proceeded to re-hash the allegations of Planned Parenthood aiding and abetting the child sex trade and the accusation that Planned Parenthood doesn't actually provide breast screenings, complete with yet another showing of the well-worn (and some have charged, doctored) videos purporting to prove those points.

Planned Parenthood Federation of America did not take the blow sitting down, and neither have allies of reproductive choice. In three days' time following Komen's announcement that they would pull funding, which amounted to \$680,000 last year and \$580,000 the year before, over \$3 million dollars poured in to Planned Parenthood from private donors all over the country.

Komen Vice President for Public Policy Karen Handel, who in an earlier gubernatorial campaign had made her anti-choice views clear (including advocating the de-funding of Planned Parenthood), resigned February 7 in the wake of the controversy. A source familiar with decision-making at Komen indicated that the decision, ostensibly to deny funding to any entity which is currently under Federal investigation, was made with the de-funding of Planned Parenthood specifically in mind. Komen's decision to pull funding came at least partially in response to the Congressional investigation launched by Rep. Cliff Stearns, R-Fla., into whether Planned Parenthood uses federal monies to pay for abortions. That investigation came at the urging of anti-choice groups including Americans United For Life.

Komen has since amended its policy to specify that such investigations must be "conclusive and criminal in nature".

The controversy has expanded to merge with the fight over the Affordable Healthcare For Americans Act, the Obama Administration's healthcare reform, which originally would have required religious institutions to provide insurance coverage for birth control tree of charge to all of their employees. In response to the outcry from anti-abortion religious forces, the President announced a compromise whereby religious institutions will not be required to pay for birth control, but their insurers must offer such coverage to any employee who desires it. The Catholic Church first indicated that this was "a step in the right direction", but later changed its tone and said that even the newest compromise violates religious freedom of conscience.

# Catholics complain about contraception coverage

The Catholic leadership objects on moral grounds to being forced to provide employee health insurance coverage for contraceptives in Catholic supported institutions like universities and hospitals even though many employees at these institutions are not Catholic.

If the Catholic Church is so concerned about the taking of innocent life, when has it ever objected to its members being forced to pay income taxes part of which are used to wage unprovoked wars which have resulted in the deaths of millions of innocent people around the world? Never.

Are Catholics being forced to take contraceptives? No. But individual Catholics would have a choice as long as contraceptives are covered. And choice is something the Catholic Church has never been able to tolerate. For hundreds of years, the Church was able to compel compliance to its dictates by everything from torture to burning people alive.
